## Quick tips for accessing care.

Whether you stay in the network to keep your health care simpler and more cost effective or you prefer the flexibility to see whomever you want, here are some things to remember.

#### If you visit an in-network health care provider,

remember to show your Cigna Healthcare/ AlKhaleej ID card and a valid form of identification - like a passport. When you visit an in-network health care provider or facility for services that are covered by your benefit plan, there are often no forms to complete or out-of-pocket costs (subject to policy terms and any applicable benefit limits and coverage exclusions).

If you visit an out-of-network health care provider, you will need to pay for the services when you are treated. While you may have some out-of-pocket costs, you can file a claim for reimbursement with a claim form. Depending on your coverage, you may be reimbursed for some or all of your costs. You can log in to CignaEnvoy.com or the mobile app to submit your claim electronically.
